#### To Redeem Your Equity Award:

- Advance to RVP
- Redeem your credits for equity awards based on your level of Net Bonusable Premium.
- Do at least \$10,000 in Net Bonusable Premium during the quarter to redeem any credits.
- For every \$1,000 in Net Bonusable Premium, at the end of the quarter, \$500 of credits will be redeemed from your "bank" for equity awards of PRI stock.
- After advancing to RVP, you have four quarters to redeem your credits.
- When you meet the requirements, the credits are automatically redeemed. How easy is that?

#### Special Info Just For Near-Term RVPs

#### How many months do I have to bank credits?

**All Future RVPs** will have a minimum of 24 months to bank up to the maximum of \$10,000 in credits. Your rolling 24-month window will start when your first credit is banked.

- If you began earning credits more than 24 months before becoming an RVP, you stop earning credits once you become an RVP.
- If you began earning credits less than 24 months before becoming an RVP, you continue earning credits after becoming an RVP - for a total of 24 months, or until you reach 10,000 in credits, then the 24-month window "stops rolling."

#### When can I start redeeming credits?

**RVPs** who are eligible to earn credits can start redeeming their credits the calendar quarter after the earlier of:

- the month your bank of credits reaches \$10,000 OR
- the month you reach the end of your 24-month earning period

Then, beginning with that quarter, credits are automatically redeemed in that quarter and the next three quarters. Once you advance to RVP, the credits you have as of the month you reach your 24 months or, if earlier, the month your bank reaches 10,000 credits, do not expire, you will have four full quarters in which to redeem them.

RVPs may not defer use of credits, which are automatically redeemed if requirements are met. Please see the Build Equity Now Program Document on Primerica Online (POL Home /Compensation).
